

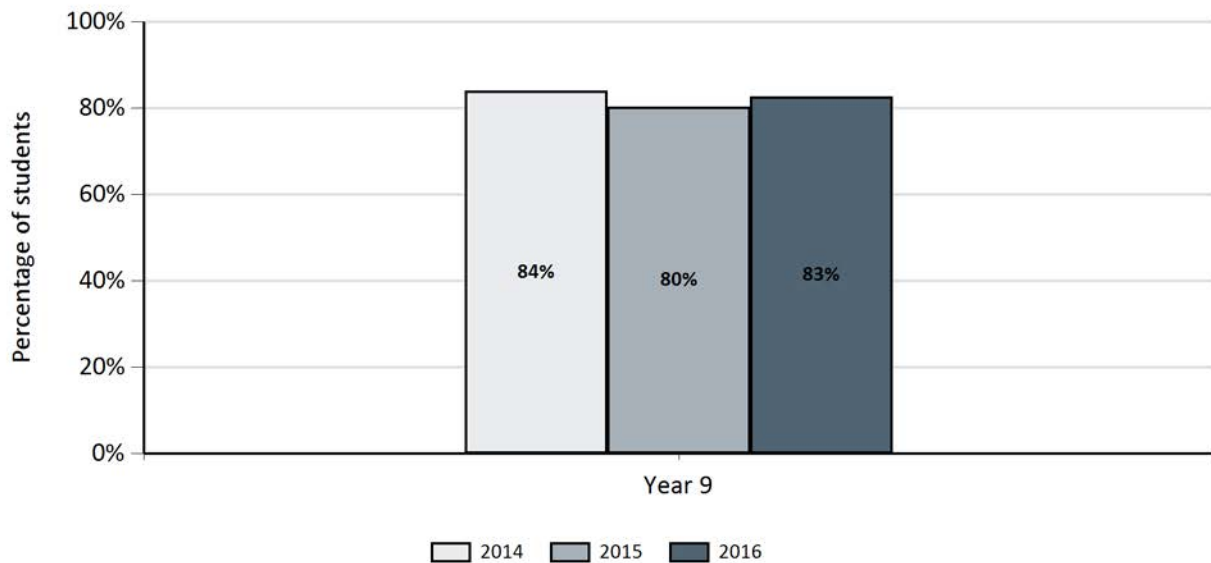

NAPLAN Proficiency

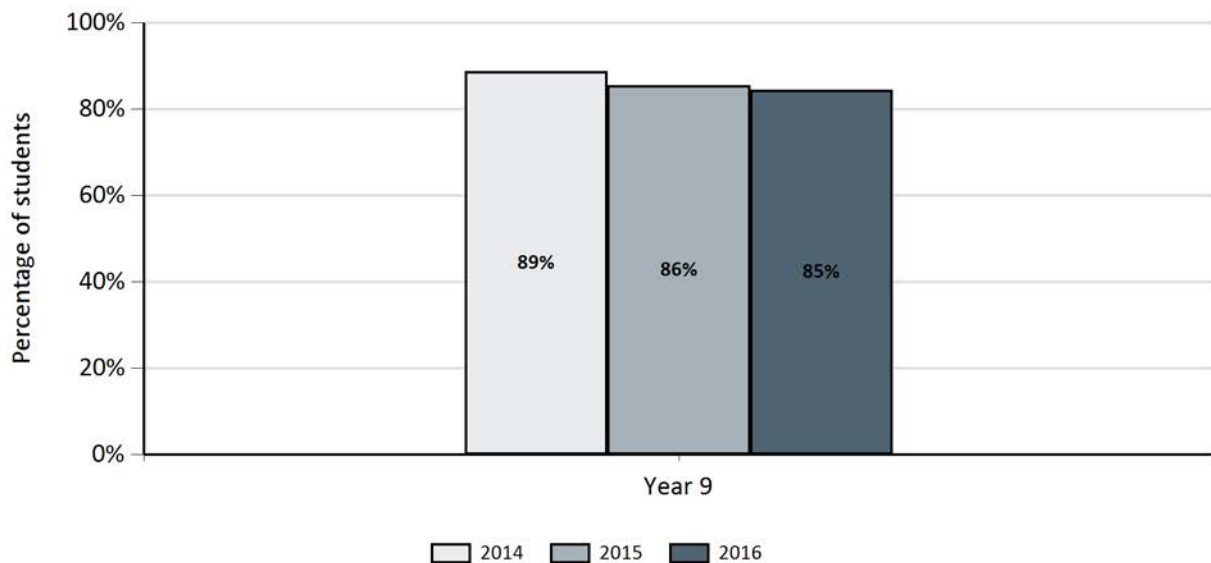
