## **2025 Payment Options for School Fees**

*Please note: An email has been sent home outlining relevant information for the 2025 School Year. Please ensure your email details are up-to-date with the school.*

**Full payment of Materials & Services Charges are payable by the 29 March 2025; unless**

- a) a School Card Application has been submitted; **or**
- b) a Student Fees Instalment Agreement has been completed.

Forms are available on the Website. Relevant forms should be completed and returned to Marryatville High School by the 28 March 2025. Outdoor Ed. (2<sup>nd</sup> Semester), Year 7 Elective Music Subject Levy (2<sup>nd</sup> Semester), and Instrument hire charges will be invoiced at a later date.

## **Payment options**

### **1. Payment of full fees by 29 March 2025**

For your convenience credit / debit card payments can be made via the Qkr smart phone app (preferred method), or via the schools website (Bpoint). Instructions to setup Qkr are available on the Website. You can also complete the banking authority, which is available on the Website to have payments directly debited from your bank account or credit card. **We strongly urge parents to pay via our smart phone app.**

### **2. Apply for the School Card Grant**

The School Card Grant is a means-tested scheme to provide assistance to families for payment of school fees.

All types of School Card applications are available online, the application form will be emailed directly to the government school(s) where the child(ren) attend, i.e. where two children attend different schools both sites will receive a copy of the application form.

**Note:** School card applications should be submitted as soon as possible via the SA Gov website - [www.sa.gov.au](http://www.sa.gov.au) under the heading of Education and Learning, Financial Support, School Card Scheme.

### **3. Payment of fees by instalments**

Parents are requested to complete the Student Fee Instalment Agreement (which is available on the Website) for **each** student by the 29 March 2025. This agreement is required for all student fees that will not be fully paid by 29 March 2025.

If you choose to have instalments automatically deducted from a credit card or bank account you must complete the Banking Direct Debit Request Form (which is available on the Website). Only one banking authority is required per family. Please allow **14 days** from the date of returning your forms (to Marryatville High School) to the start of your first payment. This allows the agreement to be processed by our office and banking institution.
